Alright, folks, we're gonna get started. Get my screen share going here. All right, welcome to the south carolina assembly outreach session today. My name is Christopher James France. I go by Chris, I live in Charleston County. And I am the South Carolina coordinator, at least for another month. Then I'll be backup coordinator and Adam. Scott spiker will take over as the coordinator. You can see the email for the coordinator is right there on the screen. And that is the blog site, South Carolina assembly dotnet. That's our website where this under the blog section, this video will be recorded and posted. And so what is the role of the coordinator? Well, it's to help grow the assembly. We're volunteers at this point, we're not being paid. Everything we do is volunteer effort for the United States of America the unincorporated, and I'll be getting into to what that is. So taken from the Declaration of Independence, you know, governments are instituted among men, deriving their just powers from the consent of the governed. That's why we're here. We're basically trying to restore our lawful government, we're doing that by keeping the peace in upholding the law. First, I want to say, we are not sovereign citizens, you might hear this term every so often, and you need to refute it. We're not that sovereign citizen is an oxymoron, you know, you're either sovereign, or you're a citizen. But the problem is the the government, the corporate government, and I'll get into that they use that term as, Oh, it's a negative, derogatory, derogatory, insurrectionists, you know, terrorism group. And that's not just, you don't want the government to call you that, you know, you refute it and say, No, we're lawful. We're peaceful. We're on the land and soil government, and we keep the peace and uphold the law, we affect the change by lawful peaceful methods, you know, in court, not with violence. So anyone looking for a violent vigilante group is not welcome here. And there have been people that have joined the assemblies across the United States that tried to get us into this, and they were guickly removed. So we tell people to, you know, treat the federal the state elios law enforcement officers with respect, they're good people. They're just doing their job. And most of them have no idea about this information that I'm presenting tonight. So you just got to remember, they are Americans as well, like we are and they are waking up. So I'm going to go through a few facts here that most people don't know. And then we'll kind of get into some of the remedies and what you can do to educate yourself. And then I'll open it up for for guestions. The plan is to talk no more than an hour tonight. I mean, actually, I'm going to talk maybe 30 minutes, and then open it up for questions. I first take the questions from people that are here live. And then I've got a list of FAQs that other people have asked in previous sessions that I'll also ask you to answer. So did you know that the United States has been bankrupt in the following years? Six years, they're 1776, all the way through 2017? Most people didn't know that we're just coming out of the last bankrupt bankruptcy. Did you know that the United States of America has a wartime in a

peacetime flag? Guess which one is the war time? If you said the one on the left, you'd be correct. That is our wartime flag that everybody knows about. Our peacetime flag is on the right. They're telling us something, they tell us we're at war. That's why we're fly that flag.

Did you know that you're you're probably not a US citizen? And what's the what's the definition of a US citizen? Well, do you live in the American Samoa, Guam or American Virgin Islands? Do you work for the federal government? Do you currently serve in the military? Are you in a political office? Have you been granted political asylum? Are you an African American and not a state citizen? And are you a welfare recipient? If you've answered no to those questions, you're not a US citizen. So you don't trust me, you don't want to be called a US citizen. Why did you know that US citizens are property? This is a Supreme Court case law. You know, basically, therefore, I'm reading to see that the US citizens residing in one of the states of the Union are classified as property and franchises of the federal government as an individual entity. So if you want to be classified as property, then then you can remain a US citizen. What we're about with the lawful assemblies is we're refuting all of this erroneous presumptions about us Americans are we Americans. So did you know that the federal government is simply your employee? They're a corporation, they were hired by the nation states to provide collective services, which include the 19 enumerated powers, which are constitutions. Most people don't know there's actually three constitutions. And I'll get into that in the next slide. And they do not apply to living people. The Declaration of Independence applies to living people. And our sovereignty is recognized in the Treaty of Paris, of 1783. Our ultimate sovereign lays come sovereignty comes from our Creator, we're given this inalienable rights, but the human government recognize it the treaty parents. So this is an eye chart, when you when you get this on the post, you can pause the video, I also put the slides out on the website. So the slide is in there. It's it's worth studying. And I'm just gonna kind of go over it real quickly. There's this above this line here. This is our lawful government. below this line, is what I would call the corporate or the fictitious government. So the union of states was founded by form formed by the Declaration of Independence. That's our national soil jurisdiction in 1776. And then, in the we got the declaration of the first Continental Congress, that holds the international jurisdiction, and that's really interaction between states, all the states of the Union are called nations. That's what's called national. And then we've had the Articles of Confederation that created the States of America. And that's the global jurisdiction if we want to do business with England, China, whatever. So you can see how they've got different names for the United States. You've got the United States, the United States of America, the states of America, all these things have meanings, particularly when they're in law documents. Well, the fledging fledgling country, we needed help, we needed services we needed outsource some of the government functions. So we created the original Constitution, which is our federal government, that's the American original Constitution. This is the kind of the the portion that has been vacant since 1860, the Civil War. And we're just as much to blame as the people that have been deceiving us because we haven't stepped up and govern. That's what the assembly is about stepping up and governing yourself holding your employees or your subcontractors accountable. Well, you've got also this other constitution, you can see we got the the constitution for the United States of America. we got the United States of America, the first one, the original one, you'll hear that that we are a republic, you've heard that, you know, this country's our republic. That is true. If you're talking about the original Constitution, if you're talking about the territorial or the British constitution, that was ratified in 1789. And that was a democracy. And you've got the different codes and federal codes and statutory

law is here. If you're ever under up in court, you're probably in a territorial court. Sometimes you're in a municipal court, that was formed in 1790. Another constitution, this is more of this is owned by the papacy, you know, the Rome Roman Catholic. And this is where you get state of Georgia State of South Carolina legal persons, all these fictions, the municipal code, the UCC, so you really got to know what kind of court you're in. And there's all kinds of presumptions on you that if you don't rebut them, they're going to stand as fact. So that's really, we've got all we have, there's only three jurisdictions, there's air, sea and land. And these are all permutations of those jurisdictions. And we are basically moving our most people when they're born, our

make sure we got all the participants in our place with their birth certificate as a territorial and municipal government citizen, and we're basically taking ourselves out of that erroneous presumption and putting us back under the Declaration of Independence where we should be. So did you know that the Federal Reserve and the IRS are private corporations and non government entities taxes are voluntary, if you do not work for the government. And this this fraud, the same fraud takes place at the state level? So the state of South Carolina is just a subsidiary of the United States ink Corporation. Did you know you're not required to pay any taxes, levies, liens, fines or other tax these private corporations might impose on you, their private corporation? This is like Amazon putting an income tax on you. You're like, What's up with this? I'm gonna get into all all this, how we, you know, remove ourselves from the system. Did you know that the government of the United States is headquartered at the White House, it's a corporation with 146 subsidiaries and 853 branches. I pulled this right out of the Dun and Bradstreet search engine. So if you guys don't know DMV is basically like the credit reporting agency for corporate I looked up some of the DMV numbers. There's the the DMV number for United States state of South Carolina has one city of Charleston county of Charleston. I even looked up the US Marshal service, you know, the, the strong arm of the law at the federal level, they're all corporations. Did you know that corporations cannot address living people unless men and women are tricked into admitting they are these artificial persons. So you can see here another US Supreme Court case, law, the legal manifestation of this is that no government as well as any law, agency, aspect, court, etc. concern itself with anything other than corporate artificial persons, and the contracts between them. So if you don't know what's going on in court, you're kind of toast because they they

ramrod you into certain presumptions. So did you know that the legal term bar you know, like a bar attorney stands for British accreditation registry, so that all lawyers, even the ones in the US pledge allegiance to the Queen first in the bar association second. And if you hire an attorney, you are their last priority. All the courts were taken over in 1954 by the British equity courts, common law is no longer recognized in their courts, but the assembly, we're bringing the common law back, that's that's some of the stuff. So that's why, you know, people have a hard time winning in court. They're in jurisdictions, they're not aware of they're hiring people. It's like asking the fox to guard the henhouse, you know, you're not going to win. Did you know that when we recite the pledge allegiance we all did when you were little kids is an undisclosed contract with the corporation. I won't read all this to you. But that's basically what it says. They're just another form of indoctrination. Did you know your identity was stolen at birth to get a birth certificate that your mother signed, an infant dusted in the seat in the state has been established in your all caps name and has been used to conduct business in your name without

you knowing it. So this is my this is a, most people have at least four names associated with them that the states create without you realizing it. This is I updated mine. And I recorded it so that I can use this to refute any presumptions that people come at me. So when you were born, your parents gave you your trade name, which is in my case, Christopher James France, which is an upper, you know, upper case, first, initial and then lowercase. So everything else is how it's written in legal documents, you've got the foreign trust, which is your state trademark trust, which is your full name, all caps, you'll see this on your driver's license and your passport. You've got the domestic transmitting utility over here on the right, it's got your all caps, you know, Christopher j, middle initial France, you'll see this in all your debt, you know, loans and stuff and so forth mortgages and auto loans. And actually with the, the conclusion of the last bankruptcy, they're starting this whole scheme again, and they're changing the transmitting utility. So now it's, if you're starting to get bills from some creditors, it'll be last name all caps, comma, you know, first name, middle initial. So there's, they're changing the way it's just all these games they play. And then you'll see this I see this nonprofit from a lot of the medical bills, hospital, things like that, you know, they'll send you an all caps, thing. So this just shows and most people are clueless, they think that you are your name. So these are like handles, it's like saying the road sign that says Charleston is Charleston, it's not it's just a sign pointing you to the actual, you know, entity. So these things are tools that we use to, to get through this this world. And part of our paperwork process. We take ownership of all these names. We say the state no longer owns them. They're ours, and we're going to control them. Did you know that the American states assembly is very close to setting up their own national trade bank, you know, all Americans will have access to prepaid vendor credit cards that are not welfare and are not benefits. These are funds that are owed to you, your parents and grandparents and great grandparents, we secured the labor bonds for billions of people's we're going to be able to discharge a variety of debt like your mortgages, medical bills, utility bills, I tell people if it doesn't motivate you to look at the assembly and join it, I don't know what will because US citizens will not be eligible for this. Only America properly declared Americans. And we have a what's called a sign in America. It's a debt relief program. It was a way that we have been processing our debt. And just this Well, I would say within three weeks, we were told not to process about it that way anymore, because the new vendor cards are going to be coming soon, hopefully in the next month or two. So this is kind of exciting times. One of them did you know that the most feared words by these corporations are I do not consent. Remember I said at the beginning, you know is this a coincidence that the Declaration of Independence said that governments are instituted among men deriving their just powers from the consent of the governed. Our American national paperwork is all about removing consent due to these uncon undisclosed contracts and putting it on the public record. Consent is natural law, also known as universal law, spiritual law, God's law of free will, and it's superior to any of man's laws, they try to dupe you to get your consent, because it works in that there's actually this this one video i thought was was really good.

Just do a search on YouTube, I put the link here, if you're looking this up later. Just search for consent, Gigi young, and it's like a six minute video, it's real, real good video to talk about what's going on with the consent, you have more power than you realize you have consent to give or withdraw. Now I'll just put a little antidote, because this just happened last night, my my wife went to the city council meeting in Charleston, because they were getting ready to vote on mandatory masks in all of Charleston County, which included schools. And most people think that they wouldn't do anything, but all these

people showed up. And I told her tell people to say I do not consent. And many of them did. And they they voted that down. They listened to the people and they did not pass mandatory masks. So you got the power of one when a lot of people come together and do not consent. Like I said, they fear that. So what is the remedy? What do we do with all this stuff? So Well, there's there's two levels, there's, I would call the individual level, and then there's the community level. at the individual level, if you don't like being lied to, or duped, or having your identity and assets stolen, then then you need to join the assembly, what we call paper up, you don't declare yourself, you want to live free and peaceful as a living man or woman on the soil as the creator intended. You don't want to pay income taxes, you want to be able to discharge your debt, be part of the national trade bank, then you need to correct your political status to an American state national, not a Democrat, not a Republican, libertarian, not a US citizen. Your nationality is your Nativity state. In my case, I was born in Ohio, I'm in Ohio, and but I'm currently domiciled in South Carolina. And notice we try to use, we try to get away from these Admiralty sea law like birth, like like a ship birth, you know, your birth certificate, what's your birthday, that's a C term. So we try to get rid of these c terms and use land terms, which is an activity. So at the community level, it's one thing you want to just, you know, Worry about yourself, take care of your family go to work, that's fine, you know, come join the assembly. But if you want to get involved in governing, and trying to hold our subcontractors accountable to these constitutional contract that we have, then you can join the assembly still need to paper up as an individual. But if you we've got all kinds of offices that you know, sheriff's available, recording secretaries, just all kinds of things that we're building our government. You don't get any of these rights that I'm talking about today, without other American states citizens stepping up and working for you. Basically, you're you're willing to serve others, instead of just worrying about your household. And we're not founding a new government. This isn't a movement. Rather, we're finishing the reconstruction as it used to be between 1776 and 1865. That's the way most people lived. During that time. We're reconstructing our lawful government and peacekeeping officers, our common law courts in the land jurisdiction, we're going to manage our employees hold them accountable to their constitutional contracts. And if they don't, if they if they don't do what we tell them to do, we have the power to fire them, just like you would at the contractor of your house. If they're not doing the job, you fire him and get somebody else, or do it yourself. And then again, we're upholding the public law, and we're keeping the peace. So what does the South Carolina What do we need? Well, we need you We need people are growing at a steady clip, we've got you know, across the nation, we have 1000s of people that are waking up and have declared their proper American status, status. We need people that are ready, willing and able to govern. A lot of people are willing, they want to do this, but they just can't find the time they're working, you know, family raising all kinds of stuff. And I get that, and you got to take care of what you got to take care of. But all of us right now, our volunteers. We don't have our state trusts yet where we can fund all this stuff. Hopefully that will be coming soon. And our goal is to have 100 and assembly members. We're about halfway there. And we've probably got Yeah, I said we got about 39 nationals papered up and we have 55 in process. So if all of those people declared we'd be pretty close to 100

American state, national To start, but we need American state citizens, you know, those willing to get involved in their government, people that want to reconstruct the government, you need to live in South Carolina for at least a year in the day to hold an office. And like I said, most of them are all volunteer. And we have most of us have day jobs, which is the way it was back in, you know, 17 1800s. You

know, people didn't do full time government. They had farms and businesses, and they went to, you know, the capital to do the government when it needed to be done. Sign in America coordinators, that's our debt relief program that's staffed, we have enough of those. But that's changing, as I mentioned, because our trade bank is coming online, the coordinator position of staff between Adam and myself, we've got a peacekeeping Task Force leader, that's the first thing we do is we need somebody to kind of take ownership of this office, and then we'll start building out we got a lot to learn, we got a lot to unlearn. And then we'll start and we're starting to populate some of these, these roles, juries and courts, we have to have our peacekeepers in place before we can enforce and vacate orders. But well, once we have that, you know, if a corporate court, you know, one of the things that that we're talking about doing is of a corporate court, you know, erroneously you know, takes your chip children away from you, oh, maybe because you didn't vaccinate them or, you know, mask them up the way they thought you should have, we can we're going to be able to make vacate those orders, and stop that kind of stuff. So because we've got more authority than they do, and you need to read and study constantly, there is a lot to learn and even more to unlearn. People say, Well, I just want a quick, five minute sound bites, you're not going to get it in five minutes, sound bites, you know, YouTube video, you've got to study, you've got to read, there's a lot of documents, you got to understand You got it, you got to get back to books. And that's what all of us are doing. So as I mentioned before, this is not a movement. It's your lawful government that has taken back the reins from these corporations. So if you like what you're heard tonight, like I said, we're gonna get into the questions here shortly. And the next steps is you got to research and you got to study, every individual has a different situation business situation. Some people are doctors, which there's issues with that, that are licensed by the corporations, if you lose your license from these corporations, you can't practice you can't get access to schedule one drugs and prescriptions and things like that. So there's things that we can do that you wouldn't lose your your livelihood, there's some people that you know, have to wait till they retire to fully paper up, you know, from they work for the military, or the federal government or whatever. And then we paper or we call paper up, you're basically there's documents that you have a witness with, like a public notary, and then you have to record it, if anybody has ever recorded in the county office, we have our own recorders, because a lot of the county offices will not record our documents because they know the power that it gives us. And all these, all these slides are going to be online. So you don't have to take pictures of the screen, but you're welcome to. And then the 928 documents that well, that's what we call full body armor documentation. The one pager the seventh 1779 is good, it's a good start, that'll get you into the assembly. But if you ever go into court, and these corporations are coming after you, if you want to be fully papered up the 928, to refute all these assumptions.

There's a new law called the source of truth of information states that American national American state nationals.org, it's got a lot of good information there. And if there's anybody listening to this later, or on the call that is not based in South Carolina, all this information applies to you, you just got to go to that that state nationals.org site and you can find your coordinator for your respective state. And we are have had, we have a mandatory class, it's mandatory in the sense that everybody has to have a basic level of knowledge on jurisdiction and what's going on in order to take part of the banking program and all that. So even if we even direct law enforcement officers to this site, and to take this class, it's like 25 bucks to take it, because it helps them understand kind of who they are and what they're doing and what they're doing wrong. And then once you're I would say once you're an American, state, national,

or you're interested, you're in the process of becoming a national, we'll invite you to our Tuesday night assembly call, we meet at eight o'clock and we go for about an hour, hour and a half. And it's on zoom as well. There's people from all over the state joining. And then once you're fully papered up, we'll give you access to our confidential it's called I'll call it a forum document forum. There's categories on how to deal with debt collectors, how to deal with courts, you know, land patents, all these various topics. And the reason we it's not like it's secret information, it's just that there's some documents in there, that if you download them and use them and serve them to the court, as a US citizen, you can end up in jail. And but you won't if you're a national, you know, American, so we want to make sure that people know what they're doing and that they're fully papered up, and there's a lot of support, there's people in within our assembly in South Carolina, and you also have access to all the all the states in all 50 states are in session. So the choice choice is yours. Everyone has a unique and personal reason for coming back to the land. And now I'll open it up for questions. We're about 25 minutes into it. So does anybody on the phone I I open it up to you first, since you took the time to actually attend in person? Do you have any questions?

I see Denise. And there's an 803 number. I don't know. If now I'm going to I have some FA Q's here. I'm going to actually up and I think I'm going to bring them up on the screen. I'm going to share, they'll probably be easier for you all to see it. All right. So does this information only apply to South Carolina? I answered that already. No, it applies to all 50 states, you just have to find your coordinator, you know, my counterpart in the other states, and they'll help you get papered up. How long once I've completed the one page process with public notary seal, can I expect to be considered a state national, just because you sign the document or autograph it in front of a notary, that does not make you a national, you actually have to record it. And that's where you put it on the public record, and it becomes law. And as soon as you do that, then you're then your national, who would be the contact for notary services with the assembly, Nicole Stewart. She's doing that. So the way the process goes, you know, the the email that I put on there, I'll have it at the end, you send an email to come to me or Adam, and we'll put you into our database. And then you'll start getting a series of emails over the next few days and weeks. It says, Alright, here's step one, do this here. Step two, do that. And it kind of kind of walks you through the details, and it gives you Nicole's email address and all that. Is it recommended to do the 928 process as opposed to the one pager? Or are they equally effective? I tell people to start with the one pager and the two witness forms because it's only three pieces of paper. And it's really easy to understand and get started the 928. It's about a 12 to 15 page document, it's a lot more complex. And you've got to understand what it is you're signing and doing. So it's going to take some time to educate but there you definitely want to do both I get asked these guestions all the time, what are the costs associated with recording documents, obtaining an ID obtaining vehicle tags, so you can get an American state national ID for 50 bucks, you actually get two cards for \$50. The recording fees, you can record them right here with the South Carolina assembly, it's \$25 per occurrence. And then it's \$2 per page to publish. So if you do your, your one pager in the to witness that's at the same time, that's an occurrence that'll be \$25. And then there's three pages, so that would be \$6. So it costs you \$31. To do that, the the 928 if you did them, you know several months later, that would be another occurrence another \$25. And then whatever 1215 pages times 230 dollars. Can I cancel my driver's license and remove the state of South Carolina plates from my car? What about my passport? NO and NO to the car. there that's just asking for trouble. Like I said, don't be afraid of quote unquote being in their system with an all caps name. Because once you go through our process, you own it all. They're your employees don't be afraid of them. And so we keep the license plates current we keep the registration current. Just so you're not hassled by all the the police. Same with the passport, there is a process to go through and get a American national passport. But most people I talked to said that once they go through it, the passport looks the same as it did before they sent it because they turned their old one in. And I don't know if it really does anything but there's ways that we mark up our our passports to let them know who we are. So you can still travel internationally and and all that so it doesn't that doesn't matter. So who can I use for witness forms? We ask anybody that that known you for at least seven years. You know, I personally picked my parents, they're still alive and I thought it would be good to have their autographs on my paperwork. So it's up to you but we need to know how they know you. You know, you got to you got to state their relationship. This is basically then someone else saying that. Yes, I know you you were born in this country and you are who you say you are. I was born in another state but I live in South Carolina. Which assembly do I join you join where you live. As I mentioned, I was born in Ohio but I live in South Carolina. So I am in the South Carolina assembly. Can somebody help me with these 928 documents? Yes, we've got a few people have angelyn at my status select has like a little service business that she does. She puts these all together. Max does the same thing could send him an email. But our recommendation is you do it yourself. Because once you do it yourself, download it read it, you end up owning it more. So either way, it's up to you, um, I had somebody helped me with mine put it together, but you have choices. What's the difference between a state national citizen, I think I mentioned that both are papered up the same, but the state citizen actually agrees to get involved in their government, govern and hold an office,

can I really stop paying taxes and get my debt discharged, and on my land with absolute free and clear allodial title, I hear this all the time, I don't want to go to jail, everybody that doesn't pay their taxes, go to jail. So let me tell you, if, if you're a US citizen, and you don't pay your taxes, then yes, you're going to go to jail. And the IRS makes that very visible. And the media really plays that up so that you are in fear of the IRS. If you're American, with properly papered up, you don't have to be in fear, because they're your employee, and all of our taxes are prepaid. And we don't have to pay taxes anymore. There's people in the assembly that haven't paid taxes in 30 years, and they're not in jail. So you've got to do it properly. Like I mentioned, debt discharged has been taken longer, but hopefully we'll have our new bank online with a vendor cards and and for an American couldn't go into this bank, get a loan for their mortgage on another \$300,000 and not have to pay it back. That's how we're that's how we're going to be given some of the money that's been stolen from our assets back to people, obviously, you just can't dump \$50 million on everybody in the country, that we'd have rampant inflation. So we're going to go through a very controlled rollout of money. And I'm not going to talk a lot about land patents. If you guys are interested in that I have a land patent on my my land here and Dunes West, if you're interested, there's all kinds of information in matter most the confidential site I mentioned. But there's ways that you can structure your your land right now the way they right now, the way it's structured is you're basically a tenant on your land, if anybody can take your house, your home and your land, because you haven't paid your taxes or you're defaulting on your mortgage, you don't really own it. A land patent makes it so that you really own it. And the taxing authorities, basically, nobody can foreclose on your house, Will I lose my social security disability or other government pensions? No, Social Security, pension is not a benefit. That's your money it was ot work your whole life you put into it. So you can get that if you're working for the Social Security, then that's a different story. You could get fired if you paper up because you have to be a US citizen working for the Social Security Administration. If I'm employed by the federal or state corporations while I get fired or lose my pension that's I just mentioned, you won't lose your pension, you might get fired. If your employment contract says you have to be a US citizen, you basically left us citizen, you broke your contract. So therefore, they can terminate you. Many people in that position, they need their pension, they need their job, and they decide to wait, just live within the system as a US citizen until they they can retire. And that's your choice. But there's also what we call a one pager that you can do as a federal or, you know, civil employee. And it's not the full protection that American nationals get. But will it'll get you more than you have as a US citizen without jeopardizing your US citizen status. Living in the private once you once the state national Do you still have to use the social security number to maintain a job and all that, like I say, yeah, you don't have to get crazy and cancel everything. Like I said, You own it all. Don't listen to other internet sites, secure party, there's other patriot groups or redemption movements, all kinds of things like that. Don't freak out. You know, it gets trickier if you're a business owner, you have an LLC or a C Corp that you're tied to, and particularly if you're a doctor, nurse, plumber that are licensed, those are things that you can you know, it's going to be on a case by case basis that we can work with the assembly if that's your issue. People asked me about David when Miller and Russell Jay Gould with their par say syntax, we basically say stay away from their dog, dog Latin and teachings, their modern day pirates. And there's Anna has written extensively on on Russell. And so we don't use any of their material banking. If no social security number, how do you obtain in the in or tin open bank accounts? Like I said, you can still continue to use your social security number, it's yours. And what but once we open up our own banks that will all change information on trust. Basically, we don't use trust, stay away from trust, you don't need them for dead people. If you've got a trust for your business or something like that, we'll have to like I said talk about that on that. case by case basis. Land patents, I'm going to skip over that.

If you need more detail on that, you know, you can reach out to the assembly that's going to be, I would say one of the last things that you worry about, you know, after you're papered up, will this process be easy? And will all the corporations recognize my new status and leave me alone? At this point? No, hardly. It's more like a target is going to be painted on your back, the goal is to lay low and not get into altercation with the federal as we call them. Our goal is to grow the assembly and restore our lawful government. But if you get engaged with them, let the assembly know and we will work with you to help you we have a litigation committee tell a story, we actually had the coordinator in Tennessee, she was pulled over because her registration on her license plates had expired. She just forgot to renew them. And they hauled her off threw in jail for a night. And, you know, if you are a US citizen, they probably give you a ticket warnings, they have this thing cleared up, you know, in the next week or whatever, but because we're nationals, and they see our paperwork, they try to intimidate us and make it difficult for us she got out and everything is alright. But like I said, you do have a target payment on your back, at least in the short term, one day, it will be reversed. I'm ticketed for speeding, arrested and not wearing a mask taking the vaccine, like I say lelo and never sign anything. Because when you sign stuff, even if I'll take it, just acknowledge you got it, don't sign it. Because it's basically your consent, you're contracting. You're consenting to contract with them in all their rules. Just don't sign anything. And contact the assembly and we'll help help you. Again, do we have a website? Yes, there's several

websites. But that's the South Carolina site. A couple more here. I'm a dual citizen. I'm a US citizen and a turkey citizen. Can I convert US citizen to American national and still retained my Turkish citizenship? No. American nationalists exclusive the founders realize you can't serve two masters that goes back to the to the Bible. American Americans are only a single citizenship. What about my IRA Roth 401k, this is kind of the bank, like I said, you own your names, nothing changes, except in the fact that you don't have to pay any more taxes, you might want to rethink your whole financial strategies, you know, what, why have things in tax free investments, if you don't pay taxes, you know, there's more restriction on all you can't take it out, you can't you get a 10% penalty, blah, blah, blah. You know, so I know a lot of people have eventually, you know, if they left their job, they rolled their stuff out into something that they could control and not worry about taxes. Taking claim. This In summary, you know, we're taking claim of all that is rightfully ours, our names, all four of them that I showed you, our state's our Federation, we own and control it all. So we don't need to exit their system and live as a hermit in the mountains. You know, we don't need to be afraid of our employees. So that's basically the quit the questions in the material I have. And they don't like that, you know, because they know that some of them, you know, the person is sitting in front of you at the loan officers, they don't generally know this, but the people at the top of the corporation and the banks, they know this, and some banks won't loan you money, if you sign it like that. Some will, you just, it may be a little harder to get loans. But hopefully, once we have our trade bank online, you won't have to worry about that you can get your your loans from from our bank, not worry about it.

So the debt is not instantaneous. It's like I said, it's, there's some people that have had their debt, you know, in the queue to process you know, over a year and the IRS, the Treasury are not doing it. That's part of the reason why we're trying to push for this vendor card, because they're just, they're just claiming they're overworked, and they don't have enough people blah, blah, blah. And but what it does what what it what it has done. So when we when we process our debt, we send it into the the IRS, which is basically like the the bankers for the or the administrative assistance for the Treasury. It goes to the Treasury, and we create what's called a payment receipt, a transmittal. So the original goes to the IRS, but then you as the as the debtor can send a notice to your creditors, that, hey, this payment is processing and all the legal laws that apply to it. And they'll generally stop collections, they'll stop foreclosures, because they know that this is a lawful method to discharge debt, and they know that it's being processed. So we've had several people that have have had issues with debt collectors and foreclosures and things like that. And our debt while their debt hasn't been fully discharged, yet, the people are not coming after them. Now, once we get these vendor cards, it'll be able to be discharged instantly, you know, electronically. But that happens, you know, you paper up, and then you have to notice, so you can't just stop paying your taxes, you have to paper up. And then you have to properly notice the IRS commissioner in two locations. And then you can then you can go and change your withholdings and stop your taxes at your employer. And then they might send you some notices, like, Hey, you pay taxes last year, but you didn't pay him this year, you know, you need to do this. And we have ways to reply to that, you know, way to mark it up and send it back. So that they leave you alone

is basically the benefit of doing this is relieving yourself of taxes and debt. And then the ultimate goal of the assembly is to get America back to its original constitutional state, I assume, right?

Correct. Yeah, most people? Yeah, most most people, I'll tell you that the biggest problem we have is that most people expect somebody else to do the government for them. They want somebody else to do it for them. And America is consent of the governed, we are the government. So because they want somebody else to do it, somebody that more than happily will step up and do that and then strip you of all your rights and your assets. So, yes, from an individual level that's attractive, oh, yeah, I can get my debt wiped out and I can not pay taxes. But there's really bigger, bigger things, you know, bigger

reasons to do this, you know, restructuring our courts, you know, not having people unlawfully arrested and thrown in jail, not having families torn apart by having their kids taken. So there's a lot bigger things than just, you know, debt and taxes. But that's kind of what gets people first interest to join the assembly. Yeah.

But right now, we just need people that are willing to volunteer.
