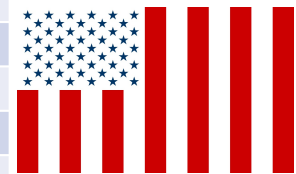
The United States of America has a Wartime and a Peacetime Flag?

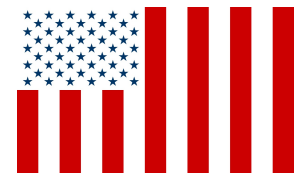


# Did You Know?

**That our Federal Government is Simply Your Employee?**

**The “Federal Government” (A Corporation) was hired by the Nation States to provide collective services; which included the “19 enumerated powers” outlined in our Constitution. US Citizens also known as Federal Workers are employed by the Corporation and the President is it’s acting “CEO”.**

The take-home message to you as an **American** is that you are most likely in the right church, but in the wrong pew. You have, most likely, been mis-identified as a **Federal Citizen** and **not** counted as an **American State National** or **American State Citizen**. Federal Citizenship is created by the Constitution(s) and therefore, **Federal Citizens** are not **Parties** to the Constitutions and have **no constitutional guarantees** --- only “Equal Civil Rights” that can be suspended. If you want to claim your “Natural and Unalienable” rights and property, you have to declare and record your political status as an American State National or American State Citizen (that is, a Member of your State Assembly) and you **cannot act as any kind of Federal United States Citizen at the same time** as you participate in your **State Assembly**. The additional message is that a large portion of your government has been “missing in action” and awaiting “Reconstruction” since the Civil War. 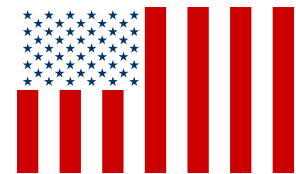
# Did You Know?

**This same fraud takes place at the State of State Level**

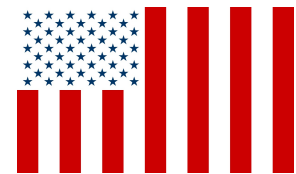


# Did You Know?

The IRS is a **PRIVATE CORPORATION**.

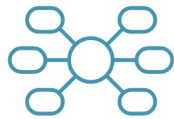
This is equivalent to Amazon requiring you to pay them a

# Did You Know?

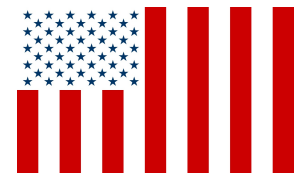


# Did You Know?

**Common Law** was no longer recognized in their Courts.

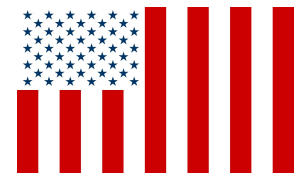

# Did You Know?

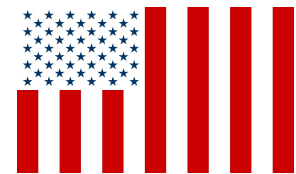
**That when we recite the Pledge of Allegiance, it is an undisclosed contract with the Corporation?**

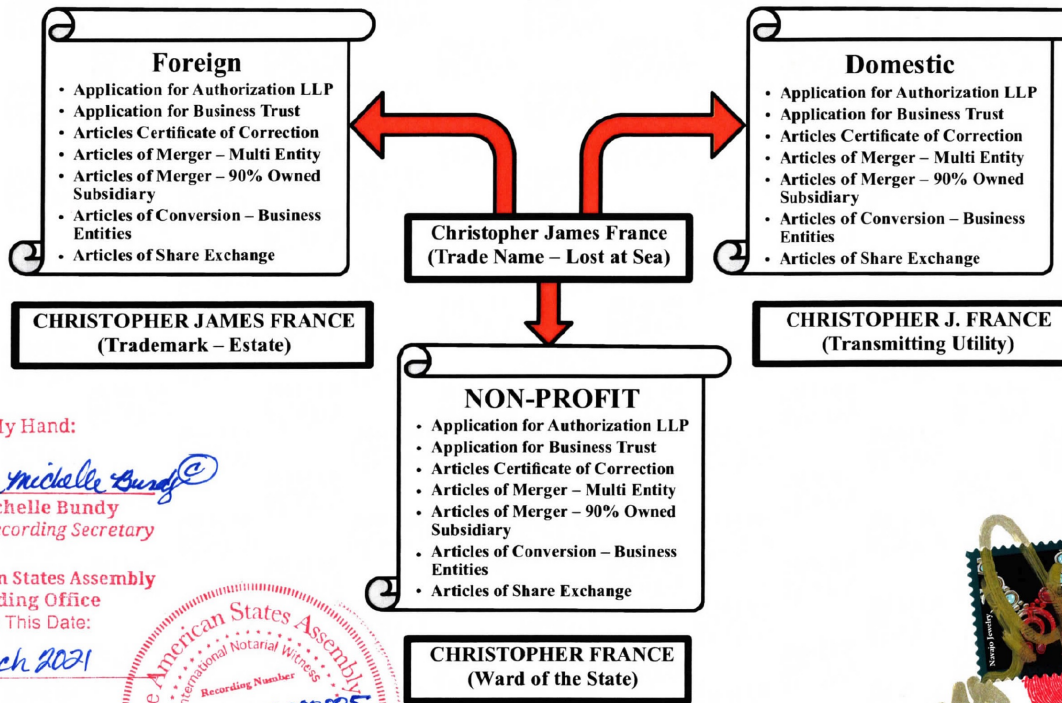

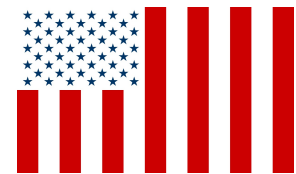
